In 2018, it launched an IPO and became a publicly listed company on Mongolian Stock Exchange with approximately shareholders.


Shareholders (2024.12.31)

Reinsurance


Since 2003, Ard Insurance JSC has consistently reinsured with major international reinsurers from countries such as the United Kingdom, the United States, Germany, Japan, Singapore, and Switzerland, all of which hold high credit ratings.

As part of a strategic partnership, we have been collaborating with Allianz Germany for the long term. Additionally, Hannover Re, Mongolian Re, and Swiss Re are among our regular reinsurers, with whom we place our risk portfolio through facultative and treaty reinsurance agreements.


Reinsurance premiums (in million MNT)

Claim

Through indexed livestock insurance, we have paid out a total of 696.8 million MNT in claims. Under our salary loan insurance partnership with Trade and Development Bank, we have provided 2.4 billion MNT in claims to 261 insured customers. Ard Insurance JSC leads the industry in claim payments, ensuring reliable compensation in accordance with insurance contracts.



Company achievements of 2024

- ✓ In 2024, we celebrated the 90th anniversary of the insurance sector and the 30th anniversary of Ard Insurance. To mark this milestone, we organized a variety of events and initiatives for our employees and customers.
- For the first time in the insurance sector, we published the "Sustainable Development Report 2023" in the insurance sector, setting a new benchmark for transparency and responsibility. This initiative serves as a model for the insurance market, the FRC, and our investors while inspiring others to adopt similar reporting practices.
- We have introduced an online system for submitting insurance claims and requesting policy cancellations, making the process more convenient and accessible for our customers.
- We have started offering online renewal of driver's TPL insurance policies via messaging services, making it easier for customers to extend their coverage.
- Launched guarantee insurance and green insurance for the first time to the market.

Interesting facts

- There are 16 insurance companies providing driver's TPL insurance, and the 2024 year-end report can be viewed in the graph.
- In 2024, the company settled claims worth 13.2 billion MNT for a total of 10,252 cases of driver's TPL insurance, which accounts for 67% of the company's total compensation.
- Approximately 90% of the above-mentioned insurance claims involve risks such as collisions, impacts, and rollovers during road traffic activities. Of the total claims, 71% are covered under driver's TPL insurance, and 29% are covered under vehicle insurance.



- Ard Insurance JSC has estimated that it pays approximately 36 million MNT in compensation to 30 policyholders every working day, solely through driver's TPL insurance.
- ▼ 50% of the total claims have been settled through the company's damage verification, while the other 50% has been resolved through the Traffic Police Department's damage verification.
